OptimiData grants you a limited, nonexclusive license to install and use the OptimiData software and accompanying Documentation as provided herein subject to the terms and restrictions set forth in this License Agreement. The licensed OptimiData software is personal to the Licensee. Licensee is not permitted to use the Software in any manner not expressly authorized by this License. Licensee acknowledges and agrees that ownership of the Software and all subsequent copies thereof regardless of the form or media are held by OptimiData or its suppliers, and the Licensee shall have no right, title, or interest therein, except as expressly set forth in this agreement.

## **DEFINITIONS:**

# *Software*:

Accompanying software program(s) delivered with download packages, including OptimiData-JPEG2000-SDK and all other deliveries as mentioned in the list of deliveries stated in the user manual.

Software provides means of exploiting the functionality of the OptimiData tools in new Applications.

## Application:

Compiled code generated using the OptimiData software, or any part thereof. No part of an application is "Software".

### Licensee:

The affiliate (a person or legal entity) which is controlled by, or controls, or is under common control with Licensee. Control means (i) beneficial ownership of at least fifty percent (50%) of the voting securities of a corporation or other business organization with voting securities, or (ii) a fifty percent (50%) or greater interest in the profits or capital of a partnership or other business organization without voting securities.

### Commercial Use:

The distribution of one or more Applications for financial return.

### Internal Use:

The use of the OptimiData software in any form by employees of Licensee or an Affiliate for the purpose of performing services on behalf of the Licensee or Affiliate, or in the performance of services for Third Parties who engage Licensee or an Affiliate for such services.

## Third Party:

Any person or legal entity which is not an Affiliate.

## LICENSE:

The Licensee shall have the right to the Commercial Use of the OptimiData software. All copies of Applications shall contain notification that they were developed using the OptimiData software.

The Licensee shall have the right to internal use of the OptimiData software.

All copies of software shall contain all copyright and proprietary notices from the original source code.

Licensee shall not use the name, trade names or trademarks of OptimiData or any of its Affiliates in any advertising, promotional literature or any other material, whether in written, electronic, or other form, distributed to any Third Party, except in the form provided by OptimiData, and then solely for purposes of identifying OptimiData software.

### NO REVERSE ENGINEERING:

Modification, reverse engineering, reverse compiling, or disassembly of the Software is expressly prohibited.

## **EXPORT RESTRICTIONS:**

You agree that you will not export or re-export the Application or accompanying documentation (or any copies thereof) or any products utilizing the Software or such documentation in violation of any applicable laws or regulations of the country in which you obtained them.

## TERM AND TERMINATION:

This License Agreement is effective until terminated.

OptimiData may terminate this license grant, by written notice to Licensee if Licensee breaches any material term of this license.

You may terminate it at any time by destroying the Software and documentation together with all copies and merged portions in any form. It will also terminate immediately if you fail to

comply with any term or condition of this License Agreement. Upon such termination you agree to destroy the Software and documentation, together with all copies.

## LIMITED WARRANTY:

SOFTWARE: OptimiData makes no warranty or representation that the operation of the software products will be uninterrupted or error free, or that all defects in the software products will be corrected.
